PROSPECTUS

THEME

Current Artist Members of the Richmond Art Center may submit ONE piece for *Members Only*. The work will be displayed in the Community Gallery. Depending on the number of submitted pieces, the work may be presented salon style (stacked.)

ELIGIBILITY

Open to all Artist, Family (one per family) and Patron Members of the Richmond Art Center.

ARTWORK SPECIFICATIONS

Only original artwork produced in the last three years and not previously displayed at RAC will be accepted. Wall hanging works may not exceed 9 square feet. Three dimensional works should be of modest scale.

ARTIST MEMBER BENEFITS

The opportunity to participate in our annual non-juried members exhibition at the Richmond Art Center. One to four artists will be selected from the members exhibition to be featured in a solo or small group exhibition the following year. Discounted rates on fees for juried exhibitions. Discounted rates on classes and workshops. Invitations to members only curator and artist led exhibition walkthroughs, as well as other special events. Free Holiday Arts Festival Silent Auction bid card.

AWARD

One-four artist(s) will be selected from *Members Only* to be featured in an exhibition in Fall 2007 in the South Gallery.

TERMS AND CONDITIONS

1. The period of the loan shall be for the duration that the artwork is at the RAC as stated on this loan agreement.
2. The lender, by mutual agreement, assumes responsibility for the transportation to and from RAC of any objects/works of art covered by this Loan Agreement, and the lender will be responsible for insuring the works while in transit unless other previous arrangements have been made. RAC will insure works of art while on RAC's premises.
3. Shipped artwork should be packed in reusable containers. Please pack carefully. Shipping costs are the responsibility of the artist.
4. Work must be framed and ready to hang.
5. RAC retains the right to remove any artwork covered by this Loan Agreement at its sole discretion.
6. RAC has the right to photograph and reproduce the works covered by this Loan Agreement for the purposes of publicity, education, documentation, exhibition publications and website.
7. RAC will retain 35% of the selling price of work sold through this exhibition. The retail price listed by artist must include the 35% commission to RAC. It is not required that work be for sale. Value must be listed for insurance purposes.
